TO THE VOLUNTARY PETITION OF ATLANTIC WIRE COMPANY, LLC

Atlantic Wire Company, LLC ("Atlantic") has its manufacturing operations at 1 Church Street in Branford, Connecticut. As part of the onsite operations, Atlantic generates hazardous waste and a permitted, treated wastewater discharge to the Branford River. For use in its production operations and its wastewater treatment system, Atlantic stores hazardous substances including, but not limited to acids, caustics, polymers, oils and other chemicals. Moreover, as part of the onsite wastewater treatment plant, Atlantic generates wastewater that is treated and discharged pursuant to a State water discharge permit and a sludge material that is shipped offsite. At any given time, Atlantic has approximately 50,000 - 100,000 gallons of wastewater and sludge in its wastewater treatment system.

Over the past few years the Environmental Protection Agency and the Department of Environmental Protection have alleged that Atlantic has had several violations of the environmental laws and unauthorized discharges to the Branford River. Additionally, in the last 10 months, Atlantic has reported spills of chemicals or discharges to the Branford River which the State authorities have alleged are in excess of permitted levels.

RESOLVED that the Company, as debtor and debtor in possession under Chapter 11 of the United States Bankruptcy Code shall be, and hereby is, authorized to (a) borrow funds from, and undertake any and all related transactions contemplated thereby (collectively, the "Financing Transactions") with such lenders and on such terms as may be approved by the Company, as reasonably necessary for the continuing conduct of the affairs of the Company; and (b) grant security interests in and liens upon some, all or substantially all of the Company's assets, as may be deemed necessary in connection with such borrowings;

RESOLVED that the Manager is authorized, empowered and directed, in the name of, and on behalf of, the Company, as debtor and debtor in possession, to take such actions and execute and deliver any and all agreements, certificates, instruments, notices and any and all other documents deemed
